3. Purpose of Processing Personal Data and Legal Basis for Processing

Brief description of the research project, particularly with regard to the processing of personal data

Research Project Name: Planetary Youth Research

Legal Basis for Processing: Scientific or historical research, statistical purposes, or exercising public authority vested in the data controller (Data Protection Act, Section 4(3)).

The research project aims to conduct diverse youth research within the broad framework of planetary youth research. The project and its associated research may also be viewed as a research program under which separate sub-projects funded independently are carried out. This privacy notice applies unless otherwise specified by a separate sub-project. The research comprehensively gathers data using multiple methods concerning young people's relationships with climate change and sustainable development (including global citizenship, relationships with nature, planetary boundaries, and future scenarios). Data collection involves ethnographic fieldwork (participant observation and interviews), surveys, and research interviews. Interviews may occur during observations or separately. Adults are also interviewed within the research project to include a generational perspective.

Young people are invited to interviews, and they may also independently express interest in participating in co-research or interviews. Names and contact information of young people interested in interviews are collected to arrange interviews. These details will be destroyed no later than at the conclusion of the project.

Participants in qualitative research will have their names and contact information collected, along with potentially their age, gender, native language, place of birth, and places of residence.

For participants under the age of 15 who consent to interviews, separate parental consent will be sought before conducting the interviews.

4. Data Content of the Registry and Categories of Individuals

For individuals consenting to research interviews, their name and contact information are recorded in the registry, along with possible details such as age, gender, native language, place of birth, and places of residence. Follow-up interviews with the same informants may be conducted during the project. The registry does not include sensitive personal data. During the project, participants may be contacted for follow-up interviews and informed about publications resulting from the research using their provided contact details.

Direct personal data is not recorded for individuals participating in surveys. The registry contains survey data including respondents' experiences, values, and attitudes, as well as their demographic and socioeconomic background information.

5. Regular Sources of Data

Description of the sources of data contained in the registry For qualitative research interviews, the sources include young people who have signed a research consent form or given consent via audio recording, consenting guardians, and interviewed adults.

The survey research registry contains survey data provided by consenting respondents aged 15–29.

6. Regular Disclosures of Data

Description of parties to whom registry data may be disclosed

Data from the research registry may be shared within the Finnish Youth Research Society (Nuorisotutkimusseura) with individuals responsible for data processing as required by the research.

The data controller will not disclose the personal data of registered individuals to external parties. Due to the technical execution of data processing, some data may physically reside on servers or equipment operated by subcontractors.

Transcription of interview materials into text format may be outsourced, at least partially, during the project. In such cases, a separate agreement will be concluded, and secure connections will be used for data transfer.

The Finnish Youth Research Society's service provider is Tahto Group Oy. The data is stored in Microsoft's Office 365 cloud service environment, protected by Microsoft user credentials and passwords. The cloud environment is ISO/IEC 27001 certified. Data centers are owned by Microsoft and are located in multiple locations within the European Union. Data centers used by Finnish customers are located in Finland, Ireland, the Netherlands, and Austria.

Survey responses may be stored in sufficiently anonymized form in the Finnish Social Science Data Archive (Yhteiskuntatieteellinen tietoarkisto) for long-term preservation.

9. Disposal or Archiving of Research Data

In addition to Research Professor Sofia Laine and researchers listed in the appendix, other researchers and research assistants designated by the data controller within the Finnish Youth Research Society may process the data as necessary.

10. Recipients or Categories of Recipients of Personal Data

Interviews will be audio-recorded and transcribed into text. During transcription, individuals' real names will be replaced with pseudonyms. Other individuals, schools, and classes will not be identified by their real names, and parental occupations will be altered to indirect identifiers. Audio recordings of interviews will be destroyed after transcription. Personal data will be retained until December 31, 2030, when the project concludes, unless separate agreements are made regarding subsequent follow-up interviews.

11. Retention Period of Personal Data

Participants in research interviews have certain rights under data protection legislation, including, in specific circumstances, the right to access and correct their personal data, as well as to transfer data from one system to another. To exercise these or other rights provided by data protection laws, participants should directly contact Sofia Laine.

Participants have the right to withdraw their consent at any time.

Participants have the right to lodge a complaint with the supervisory authority if they suspect that their personal data has been processed unlawfully.
